• Qualchan View Task Force/Update: Bob McVicars

Bob informed the Board that he was still waiting to hear back from the neighboring HOA's as to their willingness to join our task force efforts surrounding the expansion of Qualchan View Estates.

• Easements: Gibson/Withley/Johnson: Mike Durgan /Ron White Mike Durgan reviewed his conversation with the HOA lawyer, David Eash regarding our situations with the above listed names.

Gibson Flooding: The Board approved the bid from C&C to install the needed dry wells to handle the water run-off from the HOA's swale at the corner of Willapa & Lincoln. (See the attached).

Whitley Easement: With the Board's approval of the Whitley's requested easement Mike Durgan followed up with David Eash, the HOA lawyer, to draw up a formal easement agreement and to file said agreement with Spokane County. Mr. Eash agreed to have the process completed by February 1, 2021.

Pete Johnson: The issues of encroachment by Mr. Johnson has been tabled until March 2020. In November, the Board sent a letter to Mr. Johnson requesting written proof of a previous boards permission for him to use/encroach on to our common area behind his home. Mr. Johnson has not provided such proof.

- Fire Signs/Update: Mike D. & Joe V. Mike and Joe surveyed the private streets to determine the needed number of new "No Parking" sign as required by Spokane, County. The team sent their findings on to WEB for purchasing and installation.
- Snowplowing/FYI: Mike D. This item was a FYI to the Board asking for their input on the service YTD with Dundee Snowplowing. The consensus was that the service was in good standing. Mike reported that he did have to remind Dundee to clear the space in front of all mailboxes and not just the boxes on the private streets.
- Web/FYI: Ron White Ron reported that he was in the final stages of completing the 2021 Budget. He and Mike Durgan had already had discussion surrounding the need to list budget assumptions on all expense increases as well and income short falls. The board agreed to meet in a special session to review and approve the final budget on Thursday, January 14th at 2:00 PM.
