- The Board plans to have individual meetings per private road after the new Reserve Study is completed.

- Update on Neighborhood Development and Infrastructure A 160-unit home development with 40'-50' lots, so small lots, is planned and is currently being reviewed.
- There is concern about the condition of roads, routes in and out and that Latah Valley is lacking a Fire Station. With the number of homes and the risk of fire, a station is needed in this area.
- Impact fees have been paid by developers for infrastructure improvements and not sure where those funds went.
- 6 HOA's are banding together to make Qualchan Drive repairs a priority before any development is allowed.
